Areas of clinical practice:

I am now retired from NHS and Private clinical practice

I was a consultant medical oncologist for 26 years with two main subspecialty areas breast cancer and in germ-cell tumours and testicular cancer.

My NHS clinical work was divided between two organisations:

1. Calderdale & Huddersfield NHS Foundation Trust 1996 - 2020:

Until November 2020 I managed up to 100 early and advanced new breast cancers per year, providing cross-cover for an additional 100 patients cared for by a consultant colleague, and discussing 350 new cases of breast cancer at multi-disciplinary meetings each year. GIRFT Audit of Breast MDT 2018: No litigation in previous 5 years.

Until 2014, I managed up to 100 new lung cancers per year with cross-cover for an additional 100 patients per year cared for by a consultant colleague.

2. The Leeds Cancer Centre 1994 - 2020:

Unti February 2020 I was the senior member of a three-consultant team supervising the regional testicular and germ-cell cancer practice managing approximately 5-6% of the annual UK incidence of new testicular cancers (100 - 120 per annum).

In addition to the practice originating in West Yorkshire, the Leeds unit provided the multidisciplinary discussion facility for germ-cell cancers from East Yorkshire and Humber and undertook the direct care for all intermediate and poor-prognosis patients as well as relapsed patients from that area. Our MDT work, therefore covered approximately 8-9% of the UK incidence of testicular cancers.

The areas of responsibility included management of mediastinal germ-cell tumours, gynaecological malignant and immature germ-cell tumours, and germ-cell tumours in adolescents and adults originating at rarer primary sites.

I was the chairman of the National Cancer Research Institute Clinical Studies Group in Testicular Cancer for two 3-year terms (2006-2015) and a memebr of that group since its inception in 2003 until 2018. This is the National coordinating committee for testicular cancer research.

Within all practices I have been a very active participant and leader of clinical and translational research

I undertook private clinical practice until November 2020, predominantly in breast and testicular cancer, in Leeds and in Elland, West Yorkshire.

My own clinical practice has been subject to complaint in only one case over the last 10 years of my practice, which concerned the wider functioning of my MDT, not my own actions.
