Research Interests:

I have been the Principle Investigator (PI) or Co-PI for >30 clinical studies. I have published papers in peer reviewed journals and am a reviewer for several Journals. My research interests include chemotherapy in early and metastatic breast cancer, advanced radiotherapy techniques and Prostate Brachytherapy.
